Charles Law Worksheet: Answers and Explanations

Now let's look at the solutions. Understanding the process is just as important, if not more so, than getting the right answer.

Problem 1:

Convert temperatures to Kelvin: $T_1 = 25$ °C + 273.15 = 298.15 K; $T_2 = 50$ °C + 273.15 = 323.15 K

Apply Charles's Law: 2.5 L / 298.15 K = V_2 / 323.15 K Solve for V_2 : V_2 = (2.5 L 323.15 K) / 298.15 K \approx 2.71 L

Problem 2:

Apply Charles's Law: $500 \text{ mL} / 300 \text{ K} = 250 \text{ mL} / T_2$ Solve for T_2 : T_2 = (250 mL 300 K) / 500 mL = 150 KConvert to Celsius: $150 \text{ K} - 273.15 = -123.15^{\circ}\text{C}$

Problem 3:

Apply Charles's Law: $10 \text{ m}^3 / 273 \text{ K} = V_2 / 223 \text{ K}$ Solve for V_2 : $V_2 = (10 \text{ m}^3 223 \text{ K}) / 273 \text{ K} \approx 8.17 \text{ m}^3$

Problem 4:
