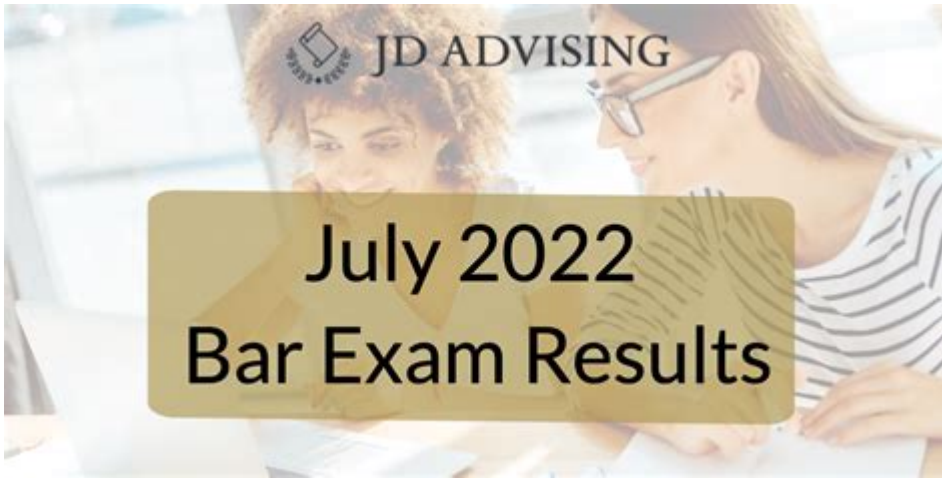

It had two products of its own being developed to prevent excessive bleeds, one of which had already cost tens of millions of dollars. The other, Factor Seven, had a more dangerous complication: its side effects could be deadly. Unwilling to let its efforts end in failure—and led by the highly influential surgeon Colonel John Holcomb—the Army set out to smear QuikClot's reputation. Over the course of six years, Hursey and Gullong engaged in an epic struggle with Holcomb for recognition.
