- Assess aPTT levels - CORRECT ANSWER-- Assess for bruising or unusual bleeding

While all options are relevant assessments, bruising or unusual bleeding can be a life threatening adverse effect of heparin treatment, and therefore needs to be the nurse's priority.

A patient who has been receiving oxycodone therapy for chronic pain reports no relief after a 10mg dose. The patient is exhibiting:

- Opioid addiction
- Opioid tolerance
- Drug-seeking behaviour
- Paradoxical CNS stimulation - CORRECT ANSWER-- Opioid tolerance

Prolonged use of opioid therapy can lead to tolerance, where a patient requires a higher dose of the drug to achieve an analgesic effect.

Which meal choice exhibits a lack of understanding of atorvastatin's drug-food interactions?
