At the beginning of 1864, Lincoln put him in charge of all federal armies, and he led the Army of the Potomac against Robert E. Lee in the Overland campaign, the siege of Petersburg, and famously, the surrender of the Army of Northern

Virginia at Appomattox. Although Grant was instrumental in winning the war and eventually parlayed his fame into two terms in the White House, his legacy and accomplishments are still the subjects of heavy debate today. His presidency is remembered mostly due to rampant fraud within his Administration, although he was never personally accused of wrongdoing, and even his victories in the Civil War have been countered by charges that he was a butcher. Like the other American Legends, much of Grant's personal life has been eclipsed by the momentous battles and events in which he participated, from Fort Donelson to the White House.
